DUST COLLECTOR consisting of: Downflo Oval 1, Model DFO 3-18, with 18 - 190 sq. ft. Ultra-Web cartridge filters, 3420 sq. ft. total area, direct drive Torit fan, 10,500 cfm @ 10" water guage, with 30 hp motor.

CONDITIONS:

1. The owner/operator (o/o) shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.
2. This dust collector shall be operated concurrent with the Abrasive Blast Booth operating under valid District permit A008832.
3. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications. This program shall include regular visible emissions observations, inspections of all associated equipment including the filters and their retaining system, and filter pressure differential measurements.
4. The o/o shall log all applicable items referenced in condition 3. The log shall also include filter replacements, repairs, and non-scheduled maintenance information. This log shall be maintained current, on-site for a minimum of five (5) years and provided to District, state or federal personnel on request.
5. The o/o shall maintain an inventory of replacement filters on-site at all times to help ensure compliance with applicable Rules of District Regulation IV.
