Description:

ODOR CONTROL SYSTEM, COATING ROOM VENT consisting of: two Calgon Corporation HIGH FLOW VENTSORB 3000 canisters with 3000 pounds of activated carbon each, in series, serving the volume exhaust of the Coating Room through 18" ducts, equipped with a 20 hp Twin City Model TBNA 20W8 forced draft fan generating 2500 cfm. Device is not equipped with an integral manometer. Equipment Elevation is 100 feet; Note: plant floor level = 100'

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. The coating room volume shall be actively vented solely through this equipment.

3. This equipment shall not discharge an air stream with detectable odor, verified by weekly odor observations after the second VENTSORB 3000 unit.

4. The owner/operator (o/o) shall maintain a log for this equipment which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:

- Weekly outlet or final sampling port odor observation date and result;
- Date of VENTSORB 3000 canister recharge or change-out; and,
