#### Description:

BAGHOUSE (FPFB3V) consisting of: Mikro Pul PulseAire model 12-6-50 TR pulsejet type baghouse with 12 polyester bags, each measuring 4.63" diameter x 42" long. Cloth area is 51 ft<sup>2</sup>, air flow is 75 ACFM. Air to Cloth ratio is 1.5:1. Fan motor is rated at 3 hp. Exhaust temperature is 150 F. Unit serves Pulverized Coal Bin, FPFB3 permitted under T010582. Facility has specified that the normal operating range for pressure differential is between 1 and 5 inches water column.

#### CONDITIONS:

- The owner/operator (o/o) shall maintain this baghouse in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.

- This baghouse shall be operated concurrently with pulverized coal bin FPFB3 (T010582).

- The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:
  - Monthly (or less frequently if allowed by a 40 CFR 63.1350 operations and maintenance plan) baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
  - Quarterly bag and bag suspension system inspection date and results;
  - Date of bag replacements; and,
  - Date and nature of any system repairs.

5.This baghouse shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty percent opacity.

6.This baghouse shall discharge no more than 0.01 pounds per hour of PM10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.
