**Description:**

ELECTROSTATIC PRECIPITATOR - SMOG HOG consisting of: United Air Specialist, Smog Hog, Model SH-10, vented to 8 inch diameter by 25' stack, with an exhaust flow rate of 500 cfm at 1432 foot/minute.

**CONDITIONS:**

1. The owner/operator (o/o) shall comply with all applicable rules and regulations of the District. Applicable rules include, but are not limited to Rules in Regulation IV. [Rule 204]
2. The o/o shall install, operate and maintain this unit in strict accord with those recommendations of the manufacturer and/or sound engineering principles which produce the minimum emissions. [Rule 204]
3. This unit shall operate concurrent with and whenever the associated coffee roaster is in operation. [Rule 204]
4. The owner/operator of the associated coffee roaster shall not process more than 528 lbs of coffee per day, and no more than 137,280 lbs in any single calendar year. [Rule 204]
5. This Authority to Construct/Permit to Operate for this control device is contingent upon compliance with District Rule 402, Nuisance. Upon receipt of a violation for this Rule, the Air Pollution Control Officer may require the owner/operator to submit, within 60 days of notification by the APCO, a permit application for an Authority to Construct additional emission control/curtail operations until either the operation can be modified or the meteorological conditions change, such that the community is no longer adversely impacted. 6. To determine compliance with the above conditions, the owner/operator shall maintain records and provide all of the data necessary to evaluate compliance with the above conditions, including, but not limited to:

- a. Monthly records of the quantity of green coffee beans roasted.
- b. Monthly usage records shall be totaled for each consecutive twelve-month period.

All records shall be retained on-site for two years, from the date of entry, and made available for Federal, State, and District personal upon request. [Rule 204]
