DUST COLLECTOR (#57) consisting of: Process Line #3, servicing the rotary valve/hopper that collects the emissions from the other two dust collectors (C011134 and C011144). A Clean Air Technologies, Model 025-DCS-084-B-C Dust Collector, 16 ounce polyester felt bags totaling 270 square feet of filter area, equipped with a fan generating 1,200 cfm of flow (for an air-to-cloth ratio of 4.44:1).
