- 3. This dust collector shall operate concurrently with the equipment described as the Oxalic Acid System under valid District permit B011859 or B011860.
- 4.The owner/operator, o/o, shall conduct the following minimum program of inspection/maintenance:
- a. Monthly visible emissions determinations; results logged;
- b. This system is equipped with an alarm which indicates when the pressure differential across the vent cartridges is out of range.

Record incidents when the pressure differential alarm is triggered and the corrective actions taken;

c. Quarterly inspections of the vent cartridges; inspections, replacements, and repairs logged.
