BIN VENT - SODA ASH SYSTEM STORAGE TANK #2 consisting of: Mikro-Pulsaire, model 20S-10-30 B style with the following specifications: Bags: 20; Total Filter Area of Bags: 236 sq ft; Flowrate: 1000 ACFM at 70 degrees Fahrenheit, ambient pressures; Air to Cloth Ratio: 4.24:1;

CONDITIONS:

1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
2. This equipment shall be operated and maintained in strict accord with the recommendations of the manufacturer or supplier and/or sound engineering principles.
3. The bin vent shall discharge no more than 0.01 grains/dscf of particulates at the operating conditions given in the above description (BACT).
4. This bin vent shall operate concurrently with the equipment described as the Soda Ash Storage Tank #2 under valid District permit T012157.

5. The owner/operator, o/o, shall conduct the following minimum program of inspection/maintenance:

- a. Monthly visible emissions determinations; results logged;
- b. Weekly readings and recording of the pressure differential across the filter;
- c. Quarterly inspections of the filter; inspections, replacements and repairs logged.

Items a, b, and c shall be logged. The log shall be maintained current, on-site for a minimum of 5 years and provided to District personnel on request.

6. The o/o shall maintain, on-site, an inventory of replacement bags sufficient to ensure compliance with the applicable rules of District Regulation IV.
