PLANT 4, TURBINE COMPRESSOR 2, SELECTIVE CATALYTIC REDUCTION (SCR) SYSTEM, PHASE I, consisting of:a catalyst and ammonia injection system located within the exhaust stack of combustion turbine compressor number 2 permitted as B012853. Manufactured by Cormetech, Model Elite. Equipment Elevation is 259 feet above sea level.

#### CONDITIONS:

1. This air pollution control device(s), shall be installed, operated, and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 2. This equipment shall be operated concurrently with the combustion turbine compressor number 2 with valid District permit B012853. [District Rule 1302(C)(2)(a); District Rule 1303(A)]
- 3.Ammonia shall be injected whenever the selective catalytic reduction system is between 400 and 900 Degrees F. Except during periods of startup and shutdown. Ammonia slip shall not exceed 20 ppmvd (corrected to 15% oxygen), averaged over three hours. [District Rule 1302(C)(2)(a); District Rule 1303(A)]
- 4. The owner/operator shall record and maintain for this equipment the following on site for a minimum of five (5) years and shall provide
