Description:

ODOR CONTROL AIR FILTRATION SYSTEM, CANNABIS CULTIVATION consisting of:Quantity of 3 Amaircare Airwash HEPA MultiPro Air Scrubbers used to control VOC and odor. Each unit uses pre-filters and a 25 lb carbon canister called a 14" Ultra VOC filter kit, with an airflow of 690 CFM with carbon canisters, power consumption is 235 Watts (2 AMP), dimensions: 19"W x 20"H x 32"L. Facility Elevation is 2940 feet above sea level.

CONDITIONS:

- 1. This air pollution control device shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2.The charcoal/carbon filters used in this Air Filtration System shall be certified by the manufacturer to have a minimum VOC control efficiency of 99.97%. In addition, the charcoal/carbon filters must be changed any time the integral sensor indicates breakthrough has occurred.

- 3.A log pertaining to the operation of this equipment shall be kept for a period of two (2) years, and must be made available upon request of District personnel. This log shall contain the following information:
- a. The date and time of each charcoal/carbon filter replacement; and,
- b. A copy of the manufacturer's certification of control efficiency for the charcoal/carbon filters. [District Rule 204]
