Description:

BIOFILTER consisting of: Treatment processes at the Water Reclamation Facility (WRF) include primary screening and flow equalization, grit removal and fine screening, biological treatment facilities, membrane bioreactor units, ultraviolet disinfection, chemical feed systems, solids dewatering system, treated effluent percolation ponds, and a biofilter odor control system. Facility elevation is 3227 feet above sea level.

CONDITIONS:

1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit to operate is issued unless otherwise noted below, and this equipment shall be properly maintained and kept in good operating condition at all times. Specifically, this equipment shall be operated and maintained so as to achieve the manufacturer's designed control efficiency for hydrogen sulfide (H₂S) of 99.9% or better.

2. This equipment shall be in operation whenever this facility is processing wastewater influent.

3. The owner/operator shall conduct odor surveys (smell test) at this facility's propertyline on a monthly basis, or more frequently as defined by the District. Any detection of odor shall be documented and corrective action shall be taken within 24 hours to reduce the odors at the propertyline to below detectable limits.

4.The biofilter media shall be replaced at a frequency that is in accordance with manufacturer's specifications. Facility shall notify the District prior to filter media replacement and/or upon odor breakthrough.

[District Rule 1302(C)(2)(a)]

5.The owner/operator shall maintain a log on-site which includes at a minimum:

a. Records of any maintenance, malfunction, and repairs (including the biofilter media change outs);

b. Record of all odor complaints and corrective actions as necessary; and

c. Results of fence line odor surveys. This log shall be maintained on-site for a minimum of two years and provided to District, State, or Federal personnel upon request.

6.The facility must submit accurate emissions inventory data to the District, in a format approved by the District, upon District request.
