#### Description:

VAPOR SCRUBBING SYSTEM, VTS 3 consisting of: Two 275 gallon totes containing solutions to neutralize emissions from VTS 3 hypergolic fuel test stand under District Permit B014533.

#### EQUIPMENT

Capacity	Equipment Description
1	One 275 gallon sealed tote containing a 6% Disodium Phosphate/2% Monosodium Phosphate by weight in deionized water solution for the purpose of neutralizing nitrogen dioxide vapor releases.
1	One 275 gallon sealed tote containing a 3% hydrogen peroxide by weight in deionized water solution for the purpose of neutralizing hydrazine and methyl hydrazine vapor releases.

#### CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]

2. This equipment shall control oxidizer and fuel vapor emissions from and be operated concurrent with the Hypergolic Fuel Test Stand under valid District Permit B014533.

3.The owner/operator shall conduct at a minimum weekly inspections of the vent lines, valves, seals, and appurtenant equipment to ensure there are no leaks. This system inspection shall include a weekly leak check using a portable/hand held hydrocarbon detector when fuel is present in the system.

[District Rule 1302]

4.The owner/operator must maintain an operations log for this equipment. This log shall be maintained current, kept for a total of two (2) years and be provided to authorized personnel upon request. The log shall contain the following at a minimum:

- a. Safety Data Sheets of solutions;
- b. The amount of fuels and oxidizer treated in this system;
- c. Dates and amounts of solution change out;
- d. Results of all weekly system inspections as required by Condition 3; and
- e. Times and durations of malfunctions, a description of each malfunction, and the corrective action taken for each malfunction.

5.This equipment does not require regular emissions testing however testing may be required at District discretion.

[District Rule 1320]

6.In the event of a malfunction of any emissions related part of this scrubber, the Hypergolic Fuel Test Stand under District Permit B014533 must be shut down as soon as safely possible and shall not be restarted until all malfunctions have been corrected.

Equipment breakdowns shall be reported to the District in accordance with District Rule 430.

7.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
