EMERGENCY ELECTRICITY GENERATOR AT BLDG 1908, WASTEWATER TREATMENT PLANT consisting of:a Perkins, diesel fueled engine driving a generator. The engine is model 825DTW-8E, serial number 3711404H-1 and is rated at approximately 110.6 bhp. The generator is an Empire, serial number 379-159 rated at 82.5 kW(e).

#### **CONDITIONS:**

- 1. Operation of this equipment shall be conducted in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
- 3. This unit shall be limited to use for emergency power, defined as when commercially available power has been interrupted, and as part of a testing program which does not exceed 8 hours of operation per month.
- 4.The owner/operator (o/o) shall use only diesel fuel whose sulfur concentration is less than or equal to 0.05% on a weight per weight basis in this unit.
- 5.The o/o shall maintain a log for this unit, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
