CONDITIONS:

- 1.The owner/operator (o/o) shall log all starting and stopping times of the test periods of this generator, to the nearest hour; the date; and the delivery of fuel.
- 2. The o/o shall comply with all applicable rules and retulations of the District.
- 3.The o/o shall not use diesel fuel whose sulfur concentration is less than or equal to .05% on w/w.
- 4.The o/o shall not use any fuel in this generator other than diesel without the written prior permission of the District. The o/o may use the supplier's sulfur analytical data, but at the discretion of the District, shall take a sample of the fuel and submit it for analysis by an independent laboratory. The results of said analyses, by ASTM method D 2622-82, shall be logged.
- 5. The o/o shall maintain the logs current, on-site for a minimum of 2 years and provided to District personnel on request.
- 6. This unit shall be used only for emergency power when commercially available power is ingterrupted. The unit may be operated
