- 2.This diesel ICE and its associated equipment cannot be operated at the same engine-print (spot) for more than 365 consecutive days, excluding time spent at a designated storage site where the engine can NOT be used for emergency use. (This generator must be moved to another facility annually for a valid operational reason.)
  [Title 17 CCR 93116]
- 3. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% or 15 ppm on a weight per weight basis per CARB Diesel or equivalent requirements.

- 4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [Title 17 CCR 93116]
- 5. This unit shall be limited to use for emergency power, defined as in response to a fire or when commercially available power has been interrupted. In addition, this unit shall be operated no more than 50 hours per year for testing and maintenance, excluding compliance source testing. Time required for source testing will not be counted toward the 50 hour per year limit.

- 6. This engine shall satisfy one of the following requirements by January 1, 2020:
- a. The portable diesel-fueled engine is certified to Tier 4 emission standards for newly manufactured nonroad engines; or
- b. The portable diesel-fueled engine is equipped with a properly functioning level-3 verified technology; or
- c. The portable diesel-fueled engine is equipped with a combination of verified emission control strategies that have been verified together to achieve at least 85 percent reduction in diesel PM emissions.

- 7. The o/o shall maintain a operations log for this unit current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date of each use:
- b. Location of each use;
- c. Duration of each use (in hours as indicated by the hour timer);
- d. Reason for each use (testing & maintenance, emergency, required emission testing);
- e. Calendar year operation in terms of fuel consumption (in gallons) or total hours; and,
- f. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log). [Title 17 CCR 93116]
- 8. The owner/operator shall not operate this emergency standby diesel-fueled CI engine for non-emergency use, including maintenance and testing, if the engine is located on school grounds whenever there is a school-sponsored activity and/or if the engine is located within 500 feet of school grounds between 7:30 a.m. and 3:30 p.m. on days when school is in session.

- 9. The owner/operator shall not operate this emergency standby diesel-fueled CI engine for non-emergency use, including maintenance and testing purposes for more than eighteen (18) hours in any one day to remain below the District's Best Available Control Technology (BACT) threshold.

- 10. This engine is subject to the requirements of the Airborne Toxic Control Measure For Diesel Particulate Matter From Portable Engines Rated At 50 Horsepower and Greater (Title 17 CCR 93116). In the event of conflict between these conditions and the ATCM, the more stringent shall govern.

11. The o/o of this engine must submit a Statement of Compliance signed by the Responsible Official that the fleet standards are being achieved and a summary that identifies each portable engine in the fleet and the associated emission rate (g/bhp-hr) and other required information, see Title 17 CCR 93116.4(e)(2), (3), (4), (5), (6) and (7) for the following compliance statement submittal dates:
