4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time.

5. The o/o shall maintain a log for this unit, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request: a. Date of each test:

b. Duration of each test, in minutes;

c. Why equipment was operated (testing & maintenance, emergency use, required emission testing)

d. Monthly usage and annual operation in terms of fuel consumption (in gallons) and total hours;

e. Retain equipment usage and fuel log for 3 years with 2 years at least onsite or at central location.

6. This unit shall be limited to use for emergency power, defined as in response to a fire or when commercially available power has been interrupted. In addition, this unit shall be operated no more than 52 hours per year for testing and maintenance, excluding compliance source testing. Time required for source testing will not be counted toward the 52 hour per year maintenance and testing limit.
