2.This unit shall be fired on PUC-regulated pipeline quality natural gas only. [40 CFR 60.4243]

This unit may be fired on propane fuel in cases of natural disaster, or when natural gas is not available. [District Rule 1302(C)(2)(a)]

- 3.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [District Rule 1302(C)(2)(a)]
- 4.This engine shall be limited to use for emergency power, defined as in response to a fire or flood, or when commercially available power has been interrupted. In addition, this engine shall be operated no more than 100 hours per year for testing and maintenance. [40 CFR 60.4243]
- 5. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of two (2) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the following information:
- a. Date of each use and duration of each use (in hours);
- b. Reason for use (testing & maintenance, emergency, required emission testing);
- c. Calendar year operation in terms of fuel consumption (in standard cubic feet or gallons) for both fuel types (natural gas and propane) or total hours; and
- d. Maintenance and repair actions, including date and description. [40 CFR 60.4243(a)(1) and 60.4245(a)(2)]
- 6.This engine is subject to 40 CFR 60, Subpart JJJJ New Source Performance Standard for Stationary Spark Ignition Internal Combustion Engines.
- 7.The facility must submit accurate emissions inventory data to the District, in a format approved by the District, upon District request. [District Rule 107(b), H&S Code 39607 & 44341-44342, and 40 CFR 51, Subpart A]
