PROPANE LPG IC ENGINE, EMERGENCY GENERATOR consisting of:USEPA engine family PPSIB5.702ED, manufactured in 2023. The exhaust flow is 553 ACFM at 1350 degrees Fahrenheit. Exhaust stack is 5.5 feet above ground level with an exhaust stack diameter 0.20 feet. Equipment is at an elevation of 384 feet above sea level.

OnePSI, Propane fired internal combustion engine Model No.5.7L and Serial No.TBD, After Cooled, producing 80.5 bhp with 8 cylinders at 1800 rpm while consuming a maximum of 339scf/hr. This equipment powers a PSIGenerator Model No.GM60-02 and Serial No.12344-1-1, rated at TBD kW.

Further, the owner/operator shall change only those emission-related settings that are permitted by the manufacturer. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. - 2.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [District Rule 1302(C)(2)(a)]
- 3. This unit shall be fired on commercial grade Liquefied Petroleum Gas (LPG) fuel only. [District Rule 1302(C)(2)(a)]
- 4.This unit shall be limited to use for emergency power, defined as in response to a fire or when commercially available power has been interrupted. This unit shall be operated for no more than 22 hours per day and no more than 100 hours per year for testing and maintenance, excluding compliance source testing. Please note there is no limitation on emergency use.

- 5.The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date of each use and duration of each use (in hours);
- b. Reason for use (testing & maintenance, emergency, required emission testing);
- c. Calendar year operation in terms of fuel consumption (in standard cubic feet or gallons) or total hours; and,
- d. Records of all inspections, maintenance and repair actions.

- 6.Engine may operate in response to notification of impending involuntary rotating outage if the area utility has ordered rotating outages in the area where the engine is located or expects to order such outages at a particular time, the engine is located in the area subject to the rotating outage, the engine is operated no more than 30 minutes prior to the forecasted outage, and the engine is shut down immediately after the utility advises that the outage is no longer imminent or in effect.

- 7. This unit shall not be used to provide power during a voluntary agreed to power outage and/or power reduction initiated under an Interruptible Service Contract (ISC), Demand Response Program (DRP), Load Reduction Program (LRP) and/or similar arrangement(s) with the electrical power supplier.
