LPG IC ENGINE, EMERGENCY GENERATOR consisting of:A Certified LPG-fired emergency internal combustion engine, USEPA PKHXB06.2NNL, manufactured in 2023. Exhaust flow is approximately 478 cfm, at 1274 degrees Fahrenheit through a 5-foot high by 2.4 inch diameter exhaust stack.

OneKohler ,LPG fired internal combustion engine Model No.KG6208 and Serial No.TBD, Three-Way Catalyst (also NSCR), After Cooled, Air-To-Fuel Ratio Controller, Charge Air Cooler, Turbo Charged, producing 103 bhp with 8 cylinders at 1800 rpm while consuming a maximum of 410scf/hr. This equipment powers a Kohler Generator Model No.KG60 and Serial No.TBD, rated at 60 kW.

Further, the owner/operator shall change only those emission-related settings that are permitted by the manufacturer. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. - 2.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [District Rule 204]
- 3.The air-to-fuel ratio controller shall be used in conjunction with the operation of the three-way catalyst, and shall be maintained and operated appropriately to ensure proper operation of the engine and control device to minimize emissions at all times.

- 4. This engine shall not be operated unless the Nett Technologies Inc. TG Series catalytic converter is properly functioning. Additionally, any modifications to this system are prohibited unless performed by a factory-certified technician or authorized in advance with written permission from the APCO.

5.This unit shall be fired on commercial grade Liquefied Petroleum Gas (LPG) fuel only. [District Rule 431]

6. This unit shall be limited to use for emergency power, defined as in response to a fire or when commercially available power has been interrupted. This unit shall be operated for no more than 100 hours per year for testing and maintenance, excluding compliance source testing.

- 7. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date of each use and duration of each use (in hours);
- b. Reason for use (testing & maintenance, emergency, required emission testing);
- c. Calendar year operation in terms of fuel consumption (in standard cubic feet or gallons) or total hours;
- d. Records of all inspections, maintenance and repair actions, and
- e. Records of all maintenance and repair actions performed the air/fuel ratio controller, and the three-way catalyst, including date and description.

8. This equipment may operate in response to an impending rotating outage if the area utility has ordered rotating outages in the area where the engine is located or expects to order such outages at a particular time. The engine may be operated no more than 30 minutes prior to the forecasted outage and must be shut down immediately after the utility advises that the outage is no longer imminent or in effect.

9. This unit shall not be used to provide power during a voluntary agreed to power outage and/or power reduction initiated under an Interruptible Service Contract (ISC), Demand Response Program (DRP), Load Reduction Program (LRP) and/or similar arrangement(s) with the electrical power supplier.

10.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
