- 3. This equipment shall be fired on pipeline quality natural gas. This equipment may be fired on propane or LPG during curtailment of natural gas supply, for testing purposes not exceeding 12 hours per year, or with the written permission of the APCO.
- 4.The incinerator shall be equipped with a primary chamber thermocouple located in the stack near the after burner.
- 5. This equipment shall be operated with a primary burner set point of at least 1750 degrees (F) and an afterburner set point of at least 1600 degrees (F).
- 6. This equipment shall not exceed 10 percent opacity as indicated on the opacity monitoring system or at the final exhaust stack, verified by quarterly stack observation.
- 7. This equipment shall not be charged with more than 300 pounds at any time.
- 8. The o/o shall have regular maintenance and inspection performed on this equipment not less frequently than annually, including quarterly on the spark plug and flame detector.
- 9. The o/o shall maintain an operational log for this equipment, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
- a. Volume of fuel used on a calendar month bases (in cubic feet or gallons);
- b. Date and number of hours of each use:
- c. Weight of each charge in pounds;
- d. Maximum opacity during each cremation;
- e. Date and results of stack observation:
- f. Date and description of quarterly and annual maintenance and inspections;
- g. Date and description of any repairs performed on this equipment.
- 10.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
