3.A temperature of not less than 1500 degrees Fahrenheit shall be maintained in the afterburner (or secondary chamber) when the equipment it serves is in operation.

[District Rule 1302]

4.The o/o shall use regulated pipeline natural gas in this equipment. When natural gas service is interrupted, the owner/operator may use LPG.

[District Rule 1302]

5. This facility shall not process more than twelve (12) bodies per day, and shall not operate more than 250 days per calendar year, and shall not operate more than 3000 hours in any single calendar year.

[District Rules 1302 and 1320]

- 6.The combined throughput of bodies processed at this facility shall not exceed 1500 any consecutive 12-month period. [District Rules 1302, 1320 and 1520]
- 7. The o/o shall maintain an operational log for this equipment. This log shall be maintained current, on-site for a minimum of two years and provided to District, State or Federal personnel on request. The log shall contain the following at a minimum:
- a. Date, weight incinerated per batch, start time of each batch, and hours operated on that day;
- b. Cumulative monthly and annual hours operated;
- c. Volume of natural gas and/or LPG used on a calendar month basis;
- d. Date and time of all upsets and/or malfunctions;
- e. A description of all repairs or maintenance performed with date performed; and,
- f. the number of bodies processed per day, per month, and per year.

- 8. The owner/operator shall operate the equipment in a manner that precludes any visible emissions from the stack. [District Rule 1302]
- 9.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
