CREMATORY, NATURAL GAS FIRED consisting of:IEE Model Super Power-Pak cremator, multiple chamber natural gas fired design with 200 lb/hr nominal burn rate, Eclipse Thermjet 150 chamber burners rated at 0.6 MM Btu/hr and 1.3 MM Btu/hr, Primary chamber is 24 square feet horizontal area, fired on natural gas or LP gas as an auxiliary fuel, 5hp blower motor.

CONDITIONS:

- 1. Operation of this equipment shall be conducted in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles.
- 3. The o/o shall maintain an operational log for this crematory. This log shall be maintained current, on-site for a minimum of two years and provided to District personnel on request. The log shall contain the following at a minimum:
- a) Date and number of bodies cremated daily,
- b) Weight of each body cremated,
- c) Start and stop time of each cremation cycle,
- d) Date and total number of hours operated daily,
- e) Volume of natural gas and/or LPG used on a calendar month basis,
- f) Date and time of all upsets and/or malfunctions, and

- g) A description of all repairs or maintenance performed by date.
- 4. This equipment shall be operated by personnel properly trained in its operation.
- 5.A temperature of not less than 1400 degrees F shall be maintained in the afterburner when the equipment it serves is in operation. Further, a secondary chamber retention time of not less than 2 seconds shall be observed.
- 6.The o/o shall use regulated pipeline natural gas in this equipment. When natural gas service is interrupted, the o/o may use LPG subsequent to proper notification of the APCO.
- 7. The total quantity of material charged per cremation cycle to this equipment must not exceed 750 pounds.
- 8. This facility shall not cremate more than 2850 bodies per calendar year at an average of 144 pounds per body. Before this annual throughput can be increased the facility may be required to submit to the District a site specific Health Risk Assessment (HRA) in accord with a District approved plan. In addition a public notice and/or comment period may be required.
- 9.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
