CONDITIONS:

1. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15ppm) on a weight per weight basis per CARB Diesel or equivalent requirements.
2. This equipment shall be operated by trained personnel; operating instructions shall be available at the incinerator at all times.
3. This unit shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier.
4. The o/o shall maintain a operations log for this unit current and on-site for a minimum of two (2) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
 - a. The dates, times and hours of operation of this equipment;
 - b. Weight of material disposed; recording daily, monthly and yearly totals; and,

5.This crematory shall only be used for disposal of animal remains.

6.Visible emissions from this equipment shall not exceed Ringelmann 1 (20%) opacity for a period or periods aggregating more than three minutes in any one hour, as required by District Rule 401, Visible Emissions.

7.This crematory incinerator may be operated concurrently with the incinerators operating under valid District Permits I005217 or I009631, co-located at this facility. Additionally, this unit may be operated a maximum of 11 hours/day, 7 days/week for a total not to exceed operation of 330 hrs/month. The total combined crematory incinerator hours shall not exceed 990 total combined hours of operation per month when all three incinerators (I005217, I009631 & I008727) operating hours are combined.
