- 2. Fuel may be dispensed out of this GDF until depleted, but shall not operate past June 30, 2009.
- 3. The owner/operator shall submit a request to Cancel Permit, to the District, no later than June 30, 2009.
- 4. The owner/operator shall maintain this equipment in accordance with Executive Order G-70-17-AD, until the time that this equipment is no longer in service.
- 5.Once fuel has been removed from tank, the tank shall be capped, and sealed so as to minimize fugitive emissions until the tank is physically removed from site.
- 6. The owner/operator (o/o) shall maintain a log of all inspections, repairs, and maintenance on equipment subject to Rule 461. Such logs or records shall be maintained at the facility for at least two (2) years and available to the District upon request.
