CONDITIONS:

1.The toll-free telephone number that must be posted is 1-800-635-4617. [District Rule 461 - Gasoline Transfer and Dispensing]

1.The owner/operator shall conspicuously post, in the gasoline dispensing area, the operating instructions and the district's toll-free telephone number for complaints (1-800-635-4617).

- 2. The owner/operator, o/o, shall maintain a log of all inspections, repairs, and maintenance on equipment subject to Rule 461. This log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.

- 2.The owner/operator shall maintain a log of all inspections, maintenance and repairs, and throughput on equipment. Such logs or records shall be maintained at the facility for at least two (2) years and shall be available to the District upon request. [District Rule 461 Gasoline Transfer and Dispensing]
- 3. Any modifications or changes to the piping or control fittings of the vapor recovery system requires prior approval from the District. [District Regulation XIII NSR]

- 4. The gasoline vapor vent pipes are to be equipped with Husky 5885 pressure relief valves or as otherwise allowed by Executive Order (EO) VR-302.

4. The gasoline vapor vent lines must be equipped with a Husky 5885 pressure/vacuum vent valve; or, as otherwise allowed by Executive Order VR-301.

- 5.The owner or operator shall conduct and pass the following tests annually using the latest adopted version of the following test procedures:
- a. Pressure Decay Tests per CARB test method TP-201.3B.
- b. Liquid Removal Test (if applicable) per TP-201.6
- c. Emergency vents and manways shall be leak free when tested at the operating pressure of the tank in accordance with CARB test methods, as specified in Title 17, California Code of Regulations.

The District shall be notified a minimum of 10 days prior to performing the required tests with the final results submitted to the District within 30 days of completion of the tests. Notification and test results should be sent to VaporRecoveryTesting@mdaqmd.ca.gov

5.The Pre-Enhanced Vapor Recovery (Pre-EVR), Phase I and II Vapor Recovery System must be tested in accordance with the requirements of CARB Executive Orders VR-301 and G-70-132-B, no later than 60 days after initial startup, and at least once every twelve (12) months using the latest adopted version of the required test procedures.

The District must be notified a minimum of 10 days prior to performing the required tests with the final results submitted to the District within 30 days of completion of the tests. Testing notifications and testing results may be sent to VaporRecoveryTesting@mdagmd.ca.gov

6. The annual throughput of gasoline shall not exceed 500,000 gallons per year. Throughput records shall be kept on site and available to District personnel upon request, and annual throughput for the previous calendar year shall be provided to the District not later than the end of February of each year. Before this annual throughput can be increased the facility may be required to submit to the District a

site specific Health Risk Assessment (HRA) in accord with a District approved plan. In addition a public notice and/or comment period may be required.

6. The annual throughput of gasoline shall not exceed 450,000 gallons per year. Throughput records shall be kept on site and available to District personnel upon request, and annual throughput for the previous calendar year shall be provided to the District not later than the end of February of each year. Before this annual throughput can be increased the facility may be required to submit to the District a site specific Health Risk Assessment (HRA) in accord with a District approved plan. In addition a public notice and/or comment period may be required.

7.The owner/operator must install, maintain, and operate this equipment in compliance with CARB Executive Order G-70-132, with the exception of the exterior coating and P/V valve configuration, which shall be in accordance with EO VR-301. Additionally, hanging hardware must be replaced with VST Balance EVR type hanging hardware during routine equipment change outs. [District Rule 461 - Gasoline Transfer and Dispensing]

7.Pursuant to California Health and Safety Code sections 39600, 39601 and 41954, this aboveground tank shall be installed and maintained in accordance with Pre-EVR Executive Order G-70-132-B for Phase I and VR-301 (Standing Loss Control). Additionally, Phase II Vapor Recovery System shall be installed and maintained per G-70-132-B with the exception that hanging hardware shall be EVR Balance Phase II type hanging hardware.

8. The owner/operator must ensure the exterior tank coating and pressure/vacuum vent valve retrofits occur no later than April 1, 2013. The owner/operator must retain records of the retrofits on site and make available to State and District personnel upon request. [District Rule 204, Executive Order VR-301]

9.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
