#### **Description:**

FIBERGLASS PRODUCT MANUFACTURING - SWIMMING POOLS consisting of: Contact Molds Resin Rollers Magnum Industries Chopper System: ATC-4000 Chopper Guns, air assisted airless coupled with the MS-1000 catalyst slave system and the RC-1000 high-torque chopper. Magnum Industries Gelcoat System: ATG-3500 Gel/Wet-out Guns coupled with the Magna-Slave catalyst pump.

#### **CONDITIONS:**

1. This equipment shall only be operated/ maintained in strict accord with manufacturers/suppliers recommendations and/or sound engineering principles.
2. The owner/operator shall maintain a log for the facility, which, at a minimum, contains the information specified below. This log shall be maintained for a minimum five (5) years, and shall be provided to District personnel on request:
  - a. Date of operation;
  - b. Manufacturer, type, and amount (in pounds or gallons) of resin, coating and solvent used (preparation, thinning, cleanup or other);
  - c. VOC content of each type of resin, coating and solvent in pounds per gallon or grams per liter or percent (weight/weight);
  - d. Keep daily records of VOC containing material and organic solvents used;
  - e. Total amount of VOC containing materials and organic solvents used per calendar month;
  - f. Calculate emissions monthly and submit reports (semi-annually and annually) as required by the Title V Permit
3. The total amount of VOC and/or organic solvents as defined in Rule 102 that can be released to the atmosphere from this facility shall not exceed 87,235 pounds (43.6175 tons) per rolling twelve calendar month period. Increasing this facility cap limit will make the facility major, triggering offsets and BACT review.
4. This facility shall comply with the applicable portions of the National Emission Standards for Hazardous Air Pollutants for Reinforced
