### **Description:**

PAINT SPRAY GUN consisting of:Spray Hand Gun described as a Brink MACH 1 HVP serial number 621-001. This equipment will be used to apply water based coatings and gray primer lacquer outside building 621.

## **CONDITIONS:**

1.All coatings, diluents, thinners and solvents shall comply with District Rules 1114, 1115, 1116 and 442 in their entirety. These rules pertain to Wood Products Coating Operations; Metal Parts & Products Coatings Operations; Automotive Refinishing Operations and Photochemically Reactive Solvents respectively.

- 2.A daily log shall be maintained which contains at least the following items:
- a. Equipment used to apply coating;
- b. Type of coating used and its VOC limit under each applicable rule;
- c. Quantity of coating used and its VOC content;
- d. Total VOC emissions; and
- e. Type of material being coated.

This log shall be kept current, on-site for a minimum of five (5) years and provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588.)

3.All equipment used at this facility shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier.

4.The total mass of VOCs emitted from this operation without regard to where or how it is generated shall be included in the facility cap for VOC.

5. This gun may be operated outside of the main areas of operation and/or a spray booth. Note: This equipment had a previous District permit, number P007993, which was cancelled at the permittees request.

6. This facility shall emit less than the following on a calendar year basis;

Oxides of Nitrogen (NOx) - 25 tons,

Volatile Organic Compound (VOC) - 25 tons,

Particulate Matter less than 10 microns (PM10) - 15 tons, and

Hazardous Air Pollutants (HAP) - 10 tons per year for any single HAP and 25 tons per year for any combination of HAPs. Compliance shall be demonstrated annually to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District no later than April 30 of each year.
