#### **Description:**

PAINT STRIPING SYSTEM (BLDG 344) consisting of: Graco LineLazer III, Model 3900, SN BA3775. Used for pavement striping.

#### **CONDITIONS:**

1. All coatings and solvents shall comply with District Rule 1113 - Architectural Coating Operations.
2. No photochemically reactive portion of the coating is permitted. This includes the coating as purchased and any solvents which may be used as diluent, thinner, reducer or cleaner.
3. The o/o shall keep the log current, on-site for a minimum of two (2) years and provide it to District personnel on request.
4. The owner/operator (o/o) shall operate only one piece of equipment described in this permit at a time and then in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emission of air contaminants.
5. The o/o shall maintain a daily log which includes all of the following:
  - a. use of all VOC, inclusive of all mentioned in Condition 1. above;
  - b. quantity and description of all VOC containing materials mentioned in Condition 1. above; and
  - c. starting and finishing times of operations.

6.The o/o shall be limited to operating to 2080 hours per calendar year.

7.This facility shall emit less than the following on a calendar year basis;

Oxides of Nitrogen (NOx) - 25 tons,

Volatile Organic Compound (VOC) - 25 tons,

Particulate Matter less than 10 microns (PM10) - 15 tons, and

Hazardous Air Pollutants (HAP) - 10 tons per year for any single HAP and 25 tons per year for any combination of HAPs.

Compliance shall be demonstrated annually to the District through the submission of a District approved

Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District each Calendar year upon request.
