PAVEMENT LINE STRIPING SYSTEM, PORTABLE consisting of:A Graco LineLazer V 200HS HP model 17K585, serial number 535 two-nozzle system. Powered by an exempt 6.5 bhp Honda model GX200 IC Engine, this equipment has a 120 lb bead storage tank and a maximum paint flow rate of 2.15 gallons per minute.

CONDITIONS:

- 1. This pavement striping system shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2.All coatings and solvents used by this system shall comply with District Rule 1113 Architectural Coating Operations. No traffic marking coatings shall exceed a VOC content of 100 grams per liter, as applied.

- 3. This system shall not be used for more than 5.5 hours in any 24 hour period. [District Rules 1303 and 1320]

- 5. The owner/operator shall maintain a daily log which includes, as a minimum, the following:
- a. Quantity and description of all VOC containing materials used;
- b. Total quantity of VOCs and each individual Hazardous Air Pollutant / Toxic Air Contaminant released into the atmosphere, in pounds; and
- c. Total hours operated.

This log shall be kept current, on-site for a minimum of three (3) years and provided to District personnel on request. [District Rule 204]

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
