SPRAY BOOTH, EPOXY PRIMER consisting of:Booth measures, 17' L x 14' W x 9' H. Exhaust filtering through 3- stages of exhaust filters. HEPA filters are used for final stage to control emissions of strontium chromate @ 99.97% efficiency. HEPA Filter Model # 01XS-24Z24Z12; size 24 X 24 X 11.5 Dimensions. Exhaust fan 10 hp motor w/ fan rating of 12600 acfm @ 2.5 water pressure differential. Booth is heated with natural gas heater to maintain 85 degree F.

#### **CONDITIONS:**

1. This equipment shall be operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. 3.All coatings, diluents, thinners and solvents, including the cleanup and storage of, shall comply with District Rules 442 - Usage of Solvents, 1115 - Metal Parts and Coating Operations, and 1118 - Aerospace Vehicle Parts and Products Coating Operations, in their entirety.

4.Discharge filters shall be installed and maintained in a tightly mounted and dimensionally stable condition, free from excessive deposits or interference with airflow passages. Differential pressure drops across the discharge filters shall be maintained with the recommendations by the manufacturer/design value.

5. Total Spray Booth VOC emissions shall be less than 7 lbs/day. [District Rule 1320 - basis: T-NSR]

6.Only High Volume Low Pressure spray equipment shall be used for applying coatings in this booth. [District Rules 1115, 1118 and 40 CFR 63, Subpart GG]

- 7.Emissions from this facility must not exceed the following limits. The owner/operator must demonstrate compliance with these facilitywide emissions limits by calculating and recording, in tons, on a calendar month basis; and, totaling each consecutive twelve-month period.
- (a) 15 tons of PM10
- (b) 25 tons of NOX
- (c) 25 tons of VOC

Emission calculations must be calculated using a District-approved method. The owner/operator shall maintain these calculations (monthly and consecutive twelve-month period totals), current and on-site (or at a central location) for a minimum of five (5) years, and must provide this data to District, State and/or Federal personnel, upon request. [District Rule 1303 - basis: offsets]

8. The owner/operator must submit a facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request. [District Rule 107(b); H&S Code 39607 & 44341-44342; and 40 CFR 51, Subpart A]
