SPRAY BOOTH AND CURING OVEN, POWDER COATING consisting of:Custom open face powder coating spray booth enclosure 10'L X 10'W X 8'H, with eight (8) cartridge exhaust filters each measuring 13.5" X 36" X 2" and six (6) second stage filters rated MERV 12 or better each measuring 20" X 20" X 6". Facility also includes a California Pulse, custom built curing oven measuring 8'H X 8'W X 20' L equipped with one propane fired burner, rated at 1 MMBtu/hr.

- b. 12 tons of PM10 per year calculated on a rolling twelve month summary basis.

- e. 80 tons of CO per year calculated on a rolling twelve month summary basis.
- f. 20 tons of SOx per year calculated on a rolling twelve month summary basis.
