#### **Description:**

STENCIL AND TOUCH-UP (AREA-A) consisting of:Paint Spray Gun(s) Binks Model 18, ML-62 & 115 Outside under canopy (48' x 30') At times this operation may be moved to another location because of winds, temperature, humidity, etc.

### **CONDITIONS:**

- 1.For the purpose of this permit the term "Organic Solvent", in addition to Rule 102, is defined to mean volatile organic portion of all paints, lacquers, stains, preservatives, diluents, thinners, reducers, cleaners, etc., used to prepare an item for coating, coat the item, and for post cleaning of the item and all equipment used in the cleaning and coating activities.
- 2. For the purpose of this permit the term "Facility" is defined to mean the "Yermo Annex".
- 3.The total amount of photochemically reactive organic solvents (Rule 102) released to the atmosphere from this paint spray area is limited to 7.9 lb/hour and 39.6 lb/day.
- 4.The total amount of non-photochemically reactive organic solvents (Rule 102) released to the atmosphere from this paint spray booth is limited to 81 lb/hour and 600 lb/day.
- 5.A daily solvent usage log shall be maintained for each permit unit with the uses and/or releases of organic solvents. This log shall contain, as a minimum, the date, hours operated, material and amount used on a daily basis. Additionally the log must contain the pressure drop across the air emission control device (Note: The daily log information provides a basis for the Toxic Emissions Inventory required by AB2588)

- 6.A daily solvent emission report for the Yermo Annex shall be prepared using the information from the above logs. This report shall contain hours operated, material and amounts used, whether the solvent is reactive or non-reactive, total daily amount of reactive and non-reactive emissions by material and facility wide. This report shall be prepared at least once each month.
- 7. Only High Volume Low Pressure (HVLP) spray guns are permitted for use.
- 8. The logs and reports shall be maintained on-site for at least two (2) years and made available to the District upon request.
- 9. This paint spray booth shall only be operated/maintained in strict accord with manufacturer's/supplier's recommendations and/or sound engineering principles.
- 10.NOTE: Currently isocyanate emissions are not regulated. However, isocyanates, along with over 500 other compounds, are listed under AB2588 "Toxic Hot Spots Program". Most users of these compounds are required to file a Toxic Emissions Inventory. Furthermore, many users will have to do a Risk Assessment. Based upon the Risk Assessment you may be required to control the emissions of the listed compounds.
