CEMENT STORAGE SILOS consisting of: Pneumatically loaded; (Three) 11,893 gallon Cement Silos; (One) 47,572 gallon Cement Silo; (One) 23,789 gallon Fly Ash Silo TOTAL: 107040 gallons

#### **CONDITIONS:**

1. This equipment shall be properly operated and maintained at all times, including assuring all hatches and doors are kept secure and closed during use and all material transfers and filter bags or cartridges are free of leaks, rips, and tears. [Rule 204]
2. This equipment shall be used for the storage and transfer of cement and fly ash material only. [Rule 204]
3. This equipment shall only vent through a properly functioning air pollution control device (bin vent). [Rule 404]
4. This equipment and associated operations shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringlemann 1). [Rule 401]
5. Cement and flyash material transfer shall only occur through the use of a pneumatic transfer system. [Rule 204]
