#### **Description:**

STORAGE TANK, MIXED ACIDS (HF, HCl AND HNO<sub>3</sub>) consisting of: Tank No. 404 (E-2), which is cross-linked polyethylene construction for concentrated hydrofluoric acid (HF), hydrochloric acid (HCl), and nitric acid (HNO<sub>3</sub>) at ambient temperature. The tank is about 10 ft in diameter by 12 ft deep with an operating capacity of 6500 gallons.

#### **CONDITIONS:**

1. This equipment shall not be operated unless it is vented to the Intergraded Dry Scrubber filled w/magnesium oxide as absorbent contained therein (55 gallon drum).

2. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:

- (a) Daily production of all pump-outs;
- (b) All additions to the tank; and,
- (c) All maintenance and repairs made on this equipment.

3.The tank shall be closed at all times when it is filled with process fluid. Only the process fluids specified (HF, HCl &HNO<sub>3</sub>) can be used in this process tank.

[District Rule 1320]

4.Emissions from this facility must not exceed the following limits. The owner/operator must demonstrate compliance with these facility-wide emissions limits by calculating and recording, in tons, on a calendar month basis; and, totaling each consecutive twelve-month period.

(a) 15 tons of PM<sub>10</sub>

(b) 25 tons of NO<sub>X</sub>

(c) 25 tons of VOC

Emission calculations must be calculated using a District-approved method. The owner/operator shall maintain these calculations (monthly and consecutive twelve-month period totals), current and on-site (or at a central location) for a minimum of five (5) years, and must provide this data to District, State and/or Federal personnel, upon request.

5.The owner/operator must submit a facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
