#### **Description:**

STORAGE TANK - MIXED ACIDS (HF, HCl AND HNO<sub>3</sub>) consisting of: Tank S-1, which is cross-linked polyethylene for concentrated acids at ambient temperatures. The tank is about 10 ft in diameter and 12 ft deep with an operating capacity of 6500 gallons.

#### **CONDITIONS:**

1. This equipment shall not be operated unless it is vented to the Integrated Dry Scrubber filled w/magnesium oxide as absorbent contained therein (55 gallon drum).

2. The facility shall maintain a log which contains at least the following:

- a. Date of inspection - monthly;
- b. All repairs/maintenance performed on equipment - updated monthly when repairs/maintenance conducted;
- c. All additions to the tank - monthly.

This log shall be maintained current, on-site for a minimum of 5 years and provided to District personnel on request.

3. The tank shall be closed at all times when it is filled with process fluid.

4. Emissions from this facility shall be less than the following limits:

- a. 15 tons of PM<sub>10</sub> calculated on a 12 month rolling sum
- b. 25 tons of NO<sub>x</sub> calculated on a 12 month rolling sum
- c. 25 tons of VOC calculated on a 12 month rolling sum

Compliance with this limit shall be verified with monthly facility emission summaries and an annual emissions inventory. Monthly

The 12 month rolling sum summary will consist of twelve monthly (July 1 to June 30) sum values.

5.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, on a yearly basis. The CEI is to be received by the District no later than April 30 of each year. District Rule 107(b) and 1303; H&S Code 39607 & 44341-44342; and 40 CFR 51, Subpart A]
