FUEL TANK FARM (Jet A) AT FIXED WING/ HELO FUEL FARM (EAF) consisting of: Any number of fuel storage (TFDS) bladders with a combined storage capacity of 100,000 gallons, manifolded together, supporting the Refueling Facility (T008628); and two 600 gallon per minute pumps powered by a 96 bhp electric motor. Fuel is Jet A.

#### CONDITIONS:

- Only Jet A jet fuel shall be stored in these bladders.
- All flanges, seals, pumps and other appurtenant equipment shall be maintained to prevent loss of volatile fractions.
- The owner/operator, o/o, shall maintain an operator's log for each tank, which at a minimum contains the following. Such a log or records shall be maintained at the facility for at least 2 years and shall be made available to the APCO upon request;
  - daily throughput, amount received and dispensed,
  - true vapor pressure of the liquid stored, and
