The owner/operator shall maintain an operator's log which, as a minimum, contains: source of liquid, date and volume (or weight) of liquid sent to outside refiners, the hauler, and results of the Reid Vapor Pressure Test, if performed. The log shall be maintained, current, on-site for a minumum of 2 years and made available to District personnel upon request.
