- 2. This equipment shall be operated and maintained in strict accord with the recommendations of its manufacturer or supplier and/or sound engineering principles.

- 3.Each petroleum product tank must be equipped with a permanent submerged fill pipe. A person shall not transfer or permit the transfer of petroleum products into this tank by any means other than the permanent submerged fill pipe.
- 4.All of the components of this tank, including but not limited to tanks, flanges, seals, pipes, pumps, valves, meters, connectors, shall be maintained and operated so as to prevent fugitive vapor leaks, fugitive liquid leaks, and excess organic liquid drainage during transfer, storage and handling operations.

- 5.The owner/operator shall maintain a log of all inspections, repairs, and maintenance on equipment. Such logs or records shall be maintained at the facility for at least two (2) years and shall be available to the District upon request. [District Rule 463]
- 6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
