NATURAL GAS ODORANT STORAGE AND INJECTION SYSTEM consisting of: NJEX Model YZ 8300 odorant injection system. This unit is electrically operated but odorant injection is achieved with a pipeline-pressure driven pump (NJEX 8000 or equivalent). This permit includes the injection system (solar panel, odorant control system, odorant metering system, odorant filtering equipment, and related appurtenances). Facility Elevation is 2496 feet above sea level.
