2. All flanges, seals, compressors, pumps, valves and other appurtenant equipment shall be inspected weekly at a minimum and maintained to prevent leakage; deficiencies shall be repaired promptly. Documentation of any inspection, maintenance, and repair events shall be kept in a log on site for a minimum of two years and provided to State, Federal, or District personal upon request. [Rule 204]

3. The owner/operator (o/o) shall maintain a daily log of the amount of ammonia received, stored, and dispensed per day. This log shall be maintained on-site for at least two years and be made available to the District upon request.
