1. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]

2. This equipment and associated operations shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringlemann 1).  
[District Rule 401]

3. The owner/operator shall demonstrate proper operation through periodic visible emissions evaluations pursuant to condition 4.  
[District Rule 401; Rule 1303]

4. The owner/operator shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:  
a. Monthly visible emissions evaluations (when silo is being filled) using EPA Method 22 (and EPA method 9 if Method 22 detects visible emissions. In lieu of Method 9, o/o may cease operations until deficiencies contributing to opacity are corrected.)  
b. Records of any maintenance and repairs.  
[District Rule 1302]

5. During silo loading operations, emissions from these storage silos shall be controlled through the use of Baghouses/Dust Collectors operating under valid District permits as noted below; the designated Baghouses shall be operated during all loading operations.  
A. During filling operations of the 50 Ton West silo and/or the 100 Ton Silo, the Raymond Mill Baghouse, with valid District Permit C000855, shall be operation.  
B. During filling operations of the 50 Ton East silo or the Fines Silo, the Raymond Mill 2" Feeder Dust Collector, with valid District Permit C003113, shall be operation.  
[District Rule 1302]

6. This facility shall emit less than the following on a calendar year basis;  
Oxides of Nitrogen (NOx) - 24.9 tons,  
Volatile Organic Compound (VOC) - 24.9 tons,  
Particulate Matter less than 10 microns (PM10) - 14.9 tons, and  
Hazardous Air Pollutants (HAP) - 9.9 tons per year for any single HAP and 24.9 tons per year for any combination of HAPs. Compliance shall be demonstrated annually to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District upon request.  
[District Rules 204 and 1303]

7. This facility is a Synthetic Minor 80 source (SM-80), therefore, it is a federally reportable facility; all applicable information shall be reported by the MDAQMD to EPA through EPA's ICIS (Integrated Compliance Information System). Information, documents, and records related to this reporting shall be provided to the MDAQMD upon request.  
[District Rule 204]

8. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
