4. A facility log shall be maintained and provided to the District personnel on request. This log shall be maintained current, on-site for a minimum of two years and shall contain the following:

- a. Daily - type and amount for each dry material used in pounds;
- b. A monthly summary of the dry materials added in pounds for the calendar year to date;
- c. Total PM emissions from each permitted process unit in pounds/month;
- d. Monthly - type and amount for each VOC containing material used in pounds; VOC content for each type of VOC containing material used in pounds per gallon
- e. Total VOC emissions in pounds/month
- f. A rolling 12 month monthly summary of the VOC emissions in pounds;
- g. Monthly emissions inventory data for all applicable non-exempt substances used for clean up and or the production of flooring adhesives on a facility wide basis
- h. MSDS for all substances used for clean up and or the production of flooring adhesives on a facility wide basis

5. Total clay added to these storage silos shall not exceed 20,280 tons per day which will limit PM10 emissions from this equipment to than 25 lbs/day. [Rule 1303 - BACT]

6. This facility shall emit less than the following on a calendar year basis:

- a. Volatile Organic Compound (VOC) - 20 tons
- b. Particulate Matter less than 10 microns (PM10) - 12 tons, and
- c. Hazardous Air Pollutants (HAP) - 8 tons per year for any single HAP and 20 tons per year for any combination of HAPs.

Compliance shall be demonstrated annually to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District no later than April 30 of each year.
