Description:

ABRASIVE BLASTER consisting of: Portable abrasive blasting unit, Schmidt, 6.5 cu. Ft., 600 lb capacity with three blast pots Serial Numbers 24L-3970, 24L-1905 and 24L-1907.

CONDITIONS:

1. The owner/operator (o/o) shall operate this equipment in strict accord with the manufacturer's specifications and/or sound engineering principles.
2. This unit shall only use abrasives that have been certified by the California Air Resources Board (CARB).
3. The o/o shall be required to comply with all the Rules and Regulations of this District. Applicable rules are included in, but not necessarily limited to, Regulations IV and XIII.
4. Dry abrasive blasting using ARB-approved abrasive and no other control shall be used only on surfaces sufficiently free of excess deposits to prevent emissions >20% opacity for more than three minutes in any one hour. Visual emissions discharged into the air from this abrasive blast unit in excess of 20% shall constitute a violation of this condition. (District Rule 401)
5. Metal fabrication operations of this facility shall be in compliance with EPA 40 CFR Part 63 Subpart XXXXXX National Emission Standards for Hazardous Air Pollutants Area Source Standards (NESHAPS) for Nine Metal Fabrication and Finishing Source Categories.

6. Facility shall conduct Method 22 visual emissions evaluations pursuant to 40 CFR Part 63 Subpart XXXXX. Any observed visual emissions leaving the facility property line shall constitute a violation of the referenced subsection.
7. Facility shall take measures to minimize excess dust.
8. Facility shall enclose abrasive material storage areas and holding bins.
9. Facility shall not re-use dry abrasive blast media.
10. Whenever practicable the facility will switch from high PM emitting blast media to lower PM emitting blast media.
11. Abrasive Blasting operations shall be conducted in compliance with the California Code of Regulations Title 17 Subchapter 6; Abrasive Blasting. In the event of conflict between permit conditions and this regulation or the NESHAPS referenced above, the more stringent requirements shall govern.
