2. Belt conveyor 511BC19 shall not be operated unless vented to baghouses C007414 (511BF106) and C007416 (511BF105). Belt conveyor 511BC25 must not be operated unless vented to baghouse C001708 (511BF051). Belt conveyor 511BC30 shall not be operated unless it is vented to baghouse C004599 (511BF061).

3. "511" equipment (clinker storage bin 511BI807 to trucks) generating fugitive dust emissions shall not discharge into the atmosphere emissions that exhibit greater than ten percent opacity.
