- 2.Screw conveyors 621SC032 and 621SC033, and bucket elevator 621BE018 must not be operated unless vented to baghouse C000162 (611BF002). Bucket elevator 621BE018 and screw conveyor 621SC030 must not be operated unless vented to C001776 (611BF001), Cyclone 621CN004 must not be operated unless vented to baghouse C001770 (621BF003). The load spout must not be operated unless it is vented to baghouse C000164 (621BF208). [District Rule 204, 1303(A)]
