**CONDITIONS:**

1. This equipment shall not be operated unless vented to air pollution control equipment operating under valid District permit C002216.
2. Materials processed shall contain sufficient natural or added moisture to ensure compliance with all applicable District Rules such as, but not limited to Rules 401, 402, and 403. Sufficient water and equipment to properly wet the material being processed shall be maintained in operable condition on-site.
3. The production rate shall not exceed 150 Cubic Yards per hour.
4. The owner/operator (o/o) shall maintain an operating log which contains at least the following information: Total tons of material fed to the system each day; maximum hourly production rate for the day in cubic yards per hour, and total hours operated each day. A copy of the log shall be kept on-site for at least two (2) years and made available to the District upon request by authorized District personnel.
5. The applicant shall comply with all applicable Rules and Regulations of this District.
6. This equipment shall only be operated/maintained in strict accord with manufacturer'/supplier's recommendations and/or sound engineering principles.
