- 1.This facility shall not treat more than 14.5 million gallons of waste water per day.
  
- 2.An operations log shall be maintained on-site for at least two (2) years and be made available to MDAQMD personnel on request. This log shall contain, as a minimum, the amount of waste water received and treated each day.
  
- 3.The applicant shall be required to comply with all applicable MDAQMD Rules and Regulations, which include the applicable rules of Regulation IV.
  
- 4.This equipment shall only be operated/maintained in strict accord with manufacturer's/supplier's recommendations; sound engineering principles; and/or federal, state, regional and local waste water discharge permits.
  
- 5.Emissions from this facility, including all stationary and portable emissions, may not exceed the following emission limits, based on a rolling 12 month summary:
  - a. NOx - 24.9 tons/year, verified by compliance tests and hours of operation,
  - b. VOC as CH4 - 24.9 tons/year, verified by compliance tests and hours of operation,
  - c. PM10 - 14.9 tons/year, verified by compliance tests and hours of operation,
  - d. Single Federal Hazardous Air Pollutant (HAP) - 9.9 ton/year, verified by emission calculations, and
  - e. All HAPs - 24.9 tons/year, verified by emission calculations.
