11.5	Grit Separation System: including one 10 hp electric motor, one 1 hp electric motor, and one 0.5 hp electric motor
1	Primary Clarifiers, Quantity 2: 248,000 gallon capacity per Clarifier. Each clarifier has one 0.5 hp electric motor each.
10	Primary Sludge Pumps, Quantity 2: Each sludge pump has one 5 hp electric motor.
15	Primary Scum Pumps, Quantity 2: Each scum pump has one 7.5 hp electric motor.
7.5	Thickener Sludge Pumps, Quantity 2: Each sludge pump has one 7.5 hp electric motor (Lead and Lag pumps)
1	Gravity Thickener: 32,000 gallon capacity with one 1 hp electric motor.
16.5	Screwpress system, including two 3 hp electric motors, two 2 hp electric motors, two 1.5 hp electric motors, two 0.75 hp electric motors, and four 0.5 hp electric motors.

- 1. This equipment shall be installed, operated, and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2.This facility shall not treat more than 4.5 million gallons of waste per day, averaged over each calendar month. [District Rule 1302]
- 3.An operations log shall be maintained on-site for at least two (2) years and be made available to District personnel on request. This log shall contain, as a minimum, the following:
- a. Amount of wastewater received and treated each day;
- b. Repairs to listed equipmient (Note: This does NOT include routine maintenance actions); and
- c. The total facility-wide Volatile Organic Compound (VOC) emissions, in pounds or tons, for the most recent calendar year. [District Rule 204]
- 4.The facility shall not discharge from any source whatsoever such quantities of air contaminants or other material which cause injury, detriment, nuisance or annoyance to any considerable number of persons or to the public, or which endanger the comfort, repose, health or safety of any such persons or the public.

- 5. This equipment shall be operated and maintained in strict accordance with applicable federal, state, regional, and local waste discharge permits.

  [District Rule 204]
- 6.Only two of the three influent pump motors may be operated simultaneously except for a 30 minute startup/shutdown period while switching from one motor to another.

  [District Rules 204 and 301]
- 7.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
