#### **Description:**

STRIP OVEN - INCINERATOR consisting of: Ramco, natural gas fired which operates between 650 - 800 degrees F. The built-in afterburner operates at 1,450 degrees F. Each of the natural gas fired processes are fired at 0.8 x 10<sup>6</sup> BTU/h at 8 in. of w.c. pressure of gas. The size of the unit is sufficient to allow the burn-off cart easy access. The dimensions of the working area above the cart inside the oven is 6'x6'x6'. Facility elevation is 3080 feet above sea level.

#### **CONDITIONS:**

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

2. This equipment is limited to using only PUC-Regulated pipeline quality natural gas for fuel.

3. This equipment shall not burn off any paint/coating that contains Chromium, Cadmium, Nickel, Manganese, or Lead. Furthermore, the facility shall not use any paint stripping compounds that contain Methylene Chloride.

4. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
  - a. Total operation time (hours per month and an annual total); and,
