SSI SHREDING SYSTEM consisting of: BUILDING 593, DRMO Scrap Yard; Shredding System Model 3400-HD, powered by 430 hp Detroit Deisel. The unit is provided with hydraulic pumps and motors, electrical, and relief pressure system. A water spray system is used for reducing particulate emissions and ease shredding some materials.

One Detroit Diesel, fired internal combustion engine Model No. and Serial No. 8VF140092, producing bhp with cylinders at rpm while consuming a maximum of 42.0 lbs/hr. This equipment powers a Model No. and Serial No., rated at.

CONDITIONS:

1. All equipment in this system shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions.
2. The owner/ operator (o/o) shall log at least the following:
 - a. all starting and stopping times, for all uses, to the nearest minute and the date.
 - B. Material type and weight shredded.
 - C. Dates and description of all maintenance or repairs.The log shall be maintained current, on-site for a minimum of two (2) years and presented to District personnel on request.
3. The o/o shall use only diesel fuel whose sulfur concentration is equal to or less than 0.05% on a per weight basis.
