**Description:**

I.C.E. - DRIVING AN ELECTRICAL GENERATOR consisting of: at AREA "R" COMPLEX, a Cummins Diesel fired, 6 cylinder engine operating at 2200 rpm. This engine drives a generator, which powers a crushing circuit. It is Cummins model 6BTA5.9P, serial number 44251559; The engine is direct injected, turbo-charged, aftercooled and the ignition timing is retarded 4 degrees.

**CONDITIONS:**

1. This engine shall operate in strict compliance with all the information submitted with the application for which this permit has been issued unless specifically exempted hereunder.
2. This engine shall not operate more than 1000 h/calendar year.
3. This engine shall be limited to the use of diesel fuel, whose sulfur concentration is less than 0.05% on a weight per weight basis.
4. The owner/operator, o/o, shall log the following information as a minimum:
  - a. Starting and stopping times each day of use from the operation meter and the date;
  - b. Fuel consumption for the day of operation, in gallons; and
  - c. All repairs and maintenance performed on the equipment in this permit.
 The log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request.
